HEALTH GUARANTEE & CONTRACT

Health

- 1) Puppy Kisses guarantees that the pup is in good health prior to delivery and has received appropriate medical inoculations and care including parvo inoculations and worming. We will provide the Buyer with a medical chart detailing all of the treatment the puppy has received while in Seller's care.
- 2) One year guarantee on any condition that caused your puppy purchased from Puppy Kisses to expire, and said expiration is confirmed to have been caused by a defect in the prenatal stage. Buyers must have an autopsy performed, at Buyer's expense, and a Veterinarian Certificate stating that the cause of death was caused by defects in the prenatal stage. Out-of-state buyers must send the Vet's report by Registered Mail. Seller's veterinarian will confirm the autopsy report.
- 3) Replacement guarantee will be terminated if the cause of death was determined to be abuse, ingesting a toxic substance, choking on a foreign object, or any condition not confirmed by veterinarian autopsy and analysis that did not stem from a defect in the prenatal stage of the puppy. Any replacement puppy will be shipped at the Buyer's expense.
- 4) Puppy Kisses does not guarantee against Hypoglycemia in puppies after 24 hours subsequent to leaving seller's premises. All puppies must be examined by a licensed veterinarian within 72 hours of purchasing the puppy. A copy of the exam must be mailed to the seller within 2 weeks of purchasing date for any guarantee to be valid. Guarantee starts at the date of purchase. This contract is only valid for the person purchasing the puppy and is null and VOID if transferred to another person.
- 5) The seller guarantee's a healthy companion pet, but does not guarantee adult size, color, and temperament. Nor does breeder guarantee fitness for breeding, i.e. fertilization in girls or non descended testacies in boys. This guarantee is VOID if puppy is bred before it reaches 12 months old.

Deposit & Purchase Contract

- 1) Deposit is accepted after the litter is whelped and the application is approved. By putting down a deposit on this puppy, the buyer understands that they are committing to this puppy, and that this deposit is non-refundable.
- 2) On rare instances, a puppy may be found unfit before shipping date. Breeder reserves the right to choose another puppy of equal value from subsequent litters with reasonable time restriction for replacement.
- 3) Payment is accepted thru money order, visa/MasterCard, PayPal. The balance owed on this puppy is due one week before the puppy is to leave. No exceptions. Seller may sell any puppy held pass the date of _____, (unless prior arrangement has been made) with Buyer forfeiting all monies and all claims to puppy.
- 4) No cash refunds will be given. Seller is not responsible for veterinarian fees.
